

TXU Energy Summer Sweepstakes Official Rules

NO PURCHASE, SCAN, OR APP REQUIRED TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. **ELIGIBILITY:** The TXU Energy Summer Sweepstakes (the “Sweepstakes”) is open only to legal residents of the State of Texas, who are at least 18 years of age or older at the time of registration and are not currently a customer of TXU Energy and are eligible to enroll in residential service with TXU Energy at a qualifying multifamily premise (e.g. did not have an account in the past that is not in good standing for any reason). Employees, officers and directors of TXU Energy Retail Company (the “Sponsor”), The Promotion House, LLC, (the “Administrator”), their respective parent companies, affiliates, subsidiaries, advertising, and fulfillment and marketing agencies (collectively, “Sweepstakes Parties”), their immediate families (parent, child, sibling and spouse and their respective spouses, regardless of where they reside) and persons living in the same households as such individuals (whether related or not) are not eligible to participate in the Sweepstakes. By participating in the Sweepstakes, you release, discharge and hold harmless Sweepstakes Parties, their respective parents, affiliates, subsidiaries, retailers, advertising and promotion agencies and the respective officers, directors, employees and agents of each of the foregoing, from any and all damages whether direct or indirect, which may be due to or arise out of participation in the Sweepstakes or any portion thereof, or the acceptance, use/misuse or possession of any prize. By participating, you agree to these Official Rules and to the decisions of the Sponsor, which are final and binding in all respects. Void where prohibited by law, rule or regulation. All federal, state and local laws and regulations apply.
2. The Sweepstakes begins at 12:01:00 PM Central Time (“CT”) on July 15, 2026 and ends at 11:59:59 PM CT on September 30, 2026 (“Sweepstakes Period”). The Sweepstakes Period is comprised of five (5) separate entry periods (each, an “Entry Period” and collectively, “Entry Periods”), as set forth in the table below.

3. HOW TO ENTER:

- a. By Enrolling in Service. To participate in the Sweepstakes, you must successfully enroll in a TXU Energy residential plan at a qualifying multifamily premise during the Sweepstakes Period. To be eligible, the enrollment must have both an enrollment date and a service start date on or after 12:01:00 PM CT on July 15, 2026 and on or before 11:59:59 PM CT on September 30, 2026. A qualifying enrollment will automatically receive one (1) entry into the drawing corresponding to the then-current Entry Period drawing and all subsequent Entry Period drawings. Enrollments with an enrollment date or a service start date outside the Sweepstakes Period are not eligible.
- b. Online Without Enrolling in Service. To enter the Sweepstakes online without enrolling in service, [click HERE](#) and follow the on-screen instructions to complete and submit your entry form to

receive one (1) entry into the drawing corresponding to the then current Entry Period drawing and all subsequent Entry Period drawings.

Limit one (1) entry per person throughout the Sweepstakes Period regardless of method of entry.

4. **DRAWINGS AND WINNER NOTIFICATION:** Administrator is an independent judging organization whose decisions as to the selection of the potential winners are final and binding. On or about each of the Draw Dates in the chart above, Administrator will select one (1) potential Entry Period prize winner from among all eligible entries received in accordance with the deadlines for that Entry Period. On or about October 7, 2026, Administrator will select the one (1) potential Grand Prize winner from among all eligible entries received in accordance with the deadlines stated for the Grand Prize drawing. The potential winners will be notified by email, or phone as applicable. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within twenty-four (24) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit their prize and an alternate winner may be selected. Sponsor, in its sole discretion and time permitting, will attempt to contact up to three (3) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if they have not complied with these Official Rules or decline the prize for any reason prior to award, such potential prize winner will be disqualified and an alternate prize winner may be selected.

5. **PRIZES/APPROXIMATE RETAIL VALUES/ODDS:**

One (1) Grand Prize is available. The Grand Prize consists of \$10,000 awarded in the form of a check made out to the Grand Prize winner.

Five (5) Entry Period Prizes (one (1) per Entry Period) are available. Each Entry Period Prize consists of \$1,000 awarded in the form of a check made out to the Entry Period Prize winner.

The ARV of all Prizes is \$15,000.

Limit one (1) Entry Period Prize per person (an individual may win one (1) Entry Period Prize and the Grand Prize). Odds of winning an Entry Period Prize depend on the total number of entries received in accordance with the deadlines for the corresponding Entry Period. Odds of winning a Grand Prize depend on the total number of entries received in accordance with the deadlines for the Grand Prize.

6. **PRIZE LIMITATIONS:** Prizes will be awarded only upon winner redemption, confirmation, verification and final approval by Sponsor. If it is discovered during prize verification you have entered, attempted to enter, or used multiple accounts to enter more than the stated limit, you will be disqualified at the discretion of the administrator, or will be void. Entries generated by script, macro or other automated means, which subvert the entry process, are void. All Entries become the property of Sponsor and will not be acknowledged or returned. Sweepstakes Parties are not responsible for late, lost, stolen, damaged, delayed, or undelivered prizes.
7. **GENERAL PRIZE CONDITIONS:** Any potential prize winner must sign and, in the case of the Grand Prize winner, have notarized an Affidavit of Eligibility, a Liability Release, and (where imposing such condition is legal) a Publicity Release and the Grand Prize winner must complete and return an IRS form W9 (collectively, **"Prize Claim Documents"**). If winner fails or refuses to sign and return all Prize Claim Documents within five (5) days of prize notification (or a shorter time if required by exigencies), winner may be disqualified and an alternate winner may be selected. Prize will only be awarded by Sponsor upon potential winners' verification of eligibility and final approval by Sponsor. No prize substitution, cash equivalent of prizes, transfer or assignment of prizes is permitted, except

by Sponsor which reserves the right to substitute a prize with one of comparable or greater value, in its sole discretion.

8. **MISCELLANEOUS:** Sweepstakes Parties are not responsible for late, lost, incomplete, corrupted, stolen, garbled, damaged, delayed, undelivered or misdirected entries, all of which are void. By entering the Sweepstakes, you recognize and agree that the registration information provided by you will be made available to Sponsor; use of such information will be governed by Sponsor's privacy policy found at <http://www.txu.com/en/ppolicy.aspx>. Upon entering the Sweepstakes, winners grant Sponsor its affiliates, subsidiaries, parents, licensees and designees the right to print, publish, broadcast, transfer, and use world-wide, in any media now known or later developed, the winner's name, photo and likeness, for publicity purposes, including but not limited to, in advertisements, and other communications, including but not limited to online and in social media, worldwide, in perpetuity, without additional compensation, notification or permission, except where prohibited by law. You agree to comply with these Official Rules and the decisions of the Sponsor and Administrator shall be binding and final.
9. **RELEASE:** As a condition of entering the Sweepstakes, you agree that (1) under no circumstances will you be permitted to obtain awards for, and you hereby waives all rights to claim punitive, incidental, consequential or any other damages, and any claims, judgments or awards shall be limited to actual out-of-pocket expenses; (2) all causes of action arising out of or connected with this Sweepstakes, or any prizes awarded, shall be resolved individually, without resort to any form class action; and (3) in no event will you be entitled to receive attorneys' fees. YOU WAIVE ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
10. **DISCLAIMER:** Sweepstakes Parties are not responsible for printing or typographical errors in these Official Rules or in any Sweepstakes-related materials. Sponsor reserves the right, in its sole discretion, to disqualify any individual that tampers with the entry process. Sponsor also reserves the right to terminate, suspend, cancel or modify the Sweepstakes and award any remaining Grand Prizes for the Sweepstakes from among all eligible, non-suspect entries received as of the date of termination in a random drawing if for any reason this Sweepstakes is not capable of running as planned due to any reason, including infection by computer virus, bugs, tampering, fraud, unauthorized intervention, technical failures or other causes that may corrupt or impair the integrity, fairness or proper play of the Sweepstakes. Sweepstakes Parties are not responsible or liable for any events which may cause errors and/or the Sweepstakes to be stopped, including but not limited to any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries, nor are they responsible for any problems or technical malfunction of any telephone, network or telephone lines, computer on-line systems, servers, or cable, satellite, or Internet Service Providers, computer equipment, software or any other failure of any email or entry to be received by Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any web site, or any combination thereof, including any injury or damage to yours or any other person's computer relating to or resulting from participation in this Sweepstakes or downloading any materials in this Sweepstakes. Sweepstakes Parties are not responsible for computer, mechanical, technical, electronic, network or other errors or problems, including any errors or problems that may occur in connection with the administration of the Sweepstakes, the processing of Entries, or in any other Sweepstakes-related materials. Sweepstakes Parties may stop you from participating in this Sweepstakes if you violate Official Rules or act, in Sponsor's sole discretion: (a) in a manner Sponsor determines to be not fair; (b) with an intent to annoy, threaten or harass any other entrant or the Sponsor; or (c) in any other disruptive manner. Should more prizes be awarded through a computer, hardware, or software malfunction, error or failure, or for any other reason, in any prize category, than

are stated for that category in the Official Rules, Sponsor reserves the right to award only the number of prizes stated in the Official Rules for that category. In no event will more prizes be awarded than that listed in Section 7.

11. **CHOICE OF LAW AND JURISDICTION:** Except where prohibited, all issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrants or winners, Sponsor, and administrator in connection with this Sweepstakes, shall be governed by, and construed in accordance with, the laws of the state of Texas, without giving effect to any choice of law or conflict of law rules or provisions (whether of the state of Texas or any other jurisdiction), which might otherwise cause the application of the laws of any jurisdiction other than the state of Texas. Any action seeking legal or equitable relief arising out of or relating to the Sweepstakes or these Official Rules shall be brought only in the courts of the state of Texas. You hereby irrevocably consent to the personal jurisdiction of said courts and waive any claim of forum non-convenience or lack of personal jurisdiction they may have.
